

Allowances in the


EU ETS Registry

Monitoring during the year



Prepare annual emissions report (ER) for each ship in THETIS MRV

Prepare company annual emissions report (CER) in THETIS MRV



Submit verified ER and CER reports in THETIS MRV



Key steps for compliance in 2024

The shipping company perspective

End 2023/beg 2024: understanding new legislative requirements

Assign MRV/ETS Responsibility (mandates, publication of attribution list)

Revision of Monitoring Plans for ships already in THETIS-MRV, submission to verifier for assessment

Submit request to open Maritime Operator Holding Accounts (MOHA) in the Union Registry

By 01.04.2024: Submit assessed Monitoring Plans to the Administering Authority for approval

Throughout 2024: continuous monitoring of emissions and other information, on the basis of the Monitoring Plan

Reporting in case of change of shipping company during the year (partial emissions reports)



31 December 2024: end of the first monitoring period




Next steps for 2025

The shipping company compliance steps in the year following the monitoring year



<u>As soon as possible</u>:

- prepare ship-level and company-level emissions reports in THETIS-MRV, covering all ships under the company's responsibility;
- ✓ submit them to your verifier(s) in THETIS-MRV;
- ✓ follow-up on the verifier report/observations (if any).







• The European Commission and EMSA have been closely monitoring key indicators of compliance through 2024:

> 17 000 Monitoring Plans submitted to Administering Authorities for approval

> Nearly 2 000 MOHAs opened

 Continuous monitoring of compliance through 2025, along with support to Member States in early detection of cases of potential non-compliance and further development of enforcement tools, including predictive tools for estimating emissions levels



State of play

Support to implementation: key tools and initiatives

The Commission and EMSA have developed a set of initiatives to support stakeholders and Member States throughout the first reporting period:

- Webinars
 - Five ETS Maritime webinars recorded and available so far on <u>climate.ec.europa ('Events'</u>)
 - Around 2 500 live participants
- Helpdesk at fitfor55@emsa.europa.eu, 1 500 MRV/ETS requests treated since late 2023
- Frequently Asked Questions on <u>MRV</u> and <u>ETS</u>, 110 questions, periodically updates
- MRV Guidance Documents revision:
 - Guidance Document no.1: General guidance for shipping companies (online)
 - Guidance Document no.2: Approval of Monitoring Plans by Administering Authorities (online)

European

- Guidance Document no.3: Verification and Accreditation (expected February 2025)
- THETIS-MRV tutorial videos revision (available online)

State of Play IT developments

The IT environment (THETIS-MRV and Union Registry) underwent major changes to support EU ETS extension to Maritime in 2024. Key developments implemented so far:

- Revised Monitoring Plan
- Attribution function
- Revised Emissions Reports, introduction of partial emissions reports function
- Maritime Operator Holding Account (MOHA) in the Union Registry

Latest key development (focus of live-demo today):

• Company-level emissions reports (incl. MyCompanies page)

State of play Legislative developments

- A total of 10 maritime-specific implementing and delegated acts are now published on the Official Journal and entered into force, all available on CLIMA webpage, under <u>'Documentation</u>'
- Among those adopted during 2024:
 - Delegated act revising MRV Annex I (offshore ships) Delegated Commission Regulation (EU) 2024/3214 published on 27.12.2024
 - > Two revisions of the list of islands and ports concerned by the ETS derogation
- No main changes to legislative framework in 2025, focus on enforcement


