

ANNEX C – Price Quotation

The price shall be quoted in Euro and in accordance with section 12 of the Tender Specifications. The percentage (%) of the brokerage fee shall be equal for all the insurance coverages.

Please note: For purposes of the evaluation the price shall be calculated without any deductibles (“franquia”) with the exception of the “admissible deductibles” as stipulated in section 2.3 of the Tender Specifications. If the tenderer can only offer an insurance policy including additional or higher deductibles than the “admissible deductibles” stipulated in section 2.3 of the Tender Specifications, they will be taken into consideration as unfavourable for the evaluation of the award criteria and will result in a lower score. On the contrary, any deductibles below the “admissible deductibles” stipulated under section 2.3 (or no deductibles) will be taken into consideration as favourable for the evaluation of the award criteria and will allow a higher score.
